Issue:

At the May 23rd meeting the Committee first considered and discussed the Discussion Document. The attached document has been updated to reflect Committee input to items #1 through #3 provided at the May Committee meeting. The Committee will continue the discussion at the June 20th meeting regarding the balance of recommendations included on the attached Discussion Document.

Background:

The MHSOAC Evaluation Committee 2012 Charter includes an activity to ensure evaluation efforts are available and useable to support the Commission's role in oversight and accountability. The MHSOAC has a contract with UCLA to provide a statewide evaluation regarding the impact of the MHSA on the public mental health system. UCLA has completed deliverables that include recommendations for the Committee to review and provide recommendations to support the Commission's role in oversight and accountability.
