Issue:

The Committee will begin initial discussion regarding the Evaluation Master Plan being developed by Dr. Joan Meisel, contractor for the MHSOAC. Dr. Meisel will provide an overview of the proposed overall approach and phases of the work plan that includes steps in the development of the Evaluation Master Plan.

The committee will be provided a presentation that outlines Dr. Meisel's proposal and be asked for input into the proposed process.

Background:

At the November 17th, 2011 Mental Health Services Oversight and Accountability Commission (MHSOAC) meeting, the Commission approved proceeding with the development of a statewide community mental health system evaluation master plan recommended by the Evaluation Committee. The master plan would provide a complete framework for evaluation of all components as a unified effort. The Committee recommended that this task be done as a collaborative effort with partners and stakeholders. The Committee also suggested that this could be a primary effort of the MHSOAC Research Scientist IV, other staff, or possibly a consultant.

The MHSOAC embarked on a search to retain a person or organization with the unique skills and knowledge to assist with the development of the Evaluation Master Plan, per the attached outline, and is pleased to announce that the Commission has retained Joan Meisel, Ph.D to lead this endeavor.

Dr. Meisel has over 40 years experience in policy analysis, research, evaluation, and consulting in the health care field with a special emphasis on mental health issues. She has worked on various aspects of the MHSA since its inception including drafting proposed performance indicators for individuals, the mental health system, and the community which were later updated and adopted by the Mental Health Planning Council and MHSOAC. Joan also co-led an evaluation of the planning and early
