## Forum Essentials

### What You Need to Know About MHSA Community Forums

- The Mental Health Services Oversight and Accountability Commission (MHSOAC) wants to hear from you.

The Commission is conducting community forums throughout California to hear firsthand from clients, parents, family members, and caregivers about their experience with the Mental Health Services Act, known as Proposition 63.

- The Commission is also seeking input from:
  - Peer Service Providers
  - County staff
  - Contract service providers
- The Commission wants to hear directly from all forum participants about what is working with the MHSA and the challenges that remain.
- The Commission encourages clients, parents, family members, caregivers, and providers from racial, ethnic and cultural groups to attend and participate in the Community Forum.

### **Community Forum Schedule**

- Before the Community Forum begins there will be resource tables set up with materials from various local mental health providers. It is expected that agencies represented will include those who serve Latinos, children and families, transition age youth, adults, older adults and college students. **The resource tables will be available from 2:00 – 3:00 PM.**
