January 28, 2009	Molly Brassil, California Primary Care Association Inquires about public comment process for Santa Rosa
January 29, 2009	Pedro Toledo speaks at MHSOAC meeting
January 29, 2009	After the MHSOAC meeting, Ann discusses issues raised by Pedro Toledo with Mike Kennedy, Sonoma County MH Director. Ann is directed to section in PEI Plan which indicates that Sonoma County set up a Latino Advisory Committee in response to Pedro’s concerns.
February 3, 2009	MHSOAC requests Additional Information for PEI Plan
February 4, 2009	Staff calls Pedro Toledo to follow-up from MHSOAC Meeting; leave message/no reply from Pedro Toledo.

February 17, 2009	Staff recommendation for approval/posted to Consent Agenda
February 18, 2009	Sherman Blackwell e-mailed Ann/Clark regarding PEI concerns
February 18, 2009	Ann speaks with Executive Management re: Sonoma in light of concerns just received in writing. Decision is made to follow MHSA Issues Resolution Process. Ann is advised to discuss with Commissioners Pating and Gould
February 18, 2009	Ann responded to Sherman and faxes copy to DMH per MHSA Issues Resolution Process
February 18, 2009	Pedro Toledo e-mails Ann w/Sherman Blackwell e-mail attachment (unable to open)
February 18, 2009	Sherman Blackwell’s e-mail to Sheri “we met at MHSOAC meeting in Santa Rosa”
February 18, 2009	Dede Ranahan, NAMI contacts Ann with questions regarding Sonoma County PEI Plan. Ann speaks with Dede and answers the questions.
February 19, 2009	Ann discusses Sonoma complaints with Commissioners Gould and Pating. Ann is directed to get additional information from Sonoma MH and discuss with Executive Management for recommendation on further action
February 19, 2009	Ann speaks with Mike Kennedy re: concerns being raised
February 20, 2009	Sonoma County letter to Sheri – responding to NAACP
February 23, 2009	Sonoma received letter from Community Action Partnership

February 24, 2009 Ann speaks with Stacie Hiramoto regarding concerns REHMDCO has received

February 24, 2009 Molly Brassil sent Sheri and e-mail re: Pedro public comment at Jan. MHSOAC meeting

February 24, 2009 Ann receives NAACP letter to Sheri dated February 11, 2009

February 25, 2009 Pedro Toledo sends Sheri e-mail 6 letters from Asian American Leaders – 3 from homeless shelter, 1 had invalid address

February 25, 2009 Michael Kennedy sends e-mail to Ann saying he is meeting with Oscar Chavez (Community Action Partnership)

February 25, 2009 Ann speaks with Commissioner Pating and he requests that Sonoma Plan be pulled from the agenda. Ann discusses with Executive Management

February 25, 2009 Ann calls Mike Kennedy and leaves a message informing him that it is likely that the Sonoma PEI Plan will be removed for the Consent Agenda and asking if he has additional last minute information that might impact this decision

February 26, 2009 Ann calls Mike Kennedy and informs him that the plan has been pulled and asks him to attend the meeting so that he can make remarks during Public Comment

February 26, 2009 Received letter of support from Southwest Community Health Center Receive copy of December 8, 2009 letter from Redwood Community Health (Pedro Toledo) to Michael Kennedy which was addressed in PEI plan

February 26, 2009 Sheri receives two additional letters from Pacific/Fiji Islander community members

February 26, 2009(11:38am) Clark phoned/e-mailed Pedro and informed him that Sonoma plan was removed from agenda

February 26, 2009(12:24pm) Pedro e-mails Clark retracting complaints and “is now in support of Sonoma Plan”

February 27, 2009 MHSOAC Meeting

March 2, 2009 Ann calls Mike Kennedy to discuss follow-up from MHSOAC meeting. Ann requests that, by March 12, 2009, Sonoma County submit an addendum to their PEI Plan which describes steps taken to address concerns raised by community members

March 2, 2009 Ann and Commissioner Pating speak with Dede Ranahan, NAMI, regarding MHSA Issues Resolution Process and possible ways to address local issues as a statewide organization

March 3, 2009 Ann discusses staff recommendation regarding lessons learned from Sonoma County with Executive Management and Commission Chair and Vice-Chair

March 3 – 8, 2009 Ann speaks with Mike Kennedy several times regarding meetings being held in Sonoma County to address community concerns

March 12, 2009 MHSOAC receives Sonoma PEI Plan with addendum

March 13, 2009 MHSOAC staff recommends Sonoma PEI Plan for approval

March 16-19, 2009 MHSOAC staff emails interested parties that Sonoma PEI Plan is on the March 26, 2009 agenda with a recommendation for approval.
