Khatera Aslami-Tamplen, Fairfield

Khatera Aslami-Tamplen has been consumer relations manager at Alameda County Behavioral Health Care Services since 2012. She was executive director at Peers Envisioning and Engaging in Recovery Services from 2007 to 2012 and served in multiple positions at the Telecare Corporation Villa Fairmont Mental Health Rehabilitation Center from 2002 to 2007, including director of rehabilitation. Commissioner Aslami-Tamplen is a founding member of the California Association of Mental Health Peer Run Organizations. Commissioner Aslami-Tamplen represents clients and consumers.

John Boyd, Psy.D., Folsom

John Boyd, PsyD., has been chief administrative officer of Regional Behavioral Health and Continuing Care at Sutter Health's Sacramento Sierra Region, including Sutter Medical Center, Sacramento, since 2008. He was assistant administrator at the Kaiser Permanente, Sacramento Medical Center from 2007 to 2008. Commissioner Boyd held positions at Shriners Hospitals for Children from 1999 to 2006. He served as a City of Sacramento Planning and Design Commissioner from 2004 to 2008. Boyd is a fellow at the American College of Healthcare Executives. Commissioner Boyd earned his Doctor of Psychology from the California School of Professional Psychology and a Master of Health Administration from University of Southern California. Commissioner Boyd represents an employer with more than 500 employees.

Bill Brown, Lompoc

Bill Brown was elected as sheriff and coroner for Santa Barbara County in 2006 and re-elected to his third term in 2014. Sheriff Brown had previously served as chief of police for the city of Lompoc from 1995 to 2007, and chief of police for the city of Moscow, Idaho from 1992 to 1995. He was a police officer, supervisor and manager for the city of Inglewood Police Department from 1980 to 1992, and a police officer for the city of Pacifica from 1977 to 1980. Prior to his law enforcement career, Sheriff Brown served as a paramedic and emergency medical technician in the Los Angeles area from 1974 to 1977. Sheriff Brown holds a master's degree in public administration from the University of Southern California and is a graduate of the Federal Bureau of Investigations, National Academy and the Delinquency Control Institute. Commissioner Brown fills the county sheriff seat.

John Buck, Folsom

John Buck has served in multiple positions at Turning Point Community Programs since 1977, including Chief Executive Officer. He is a member of the Rotary Club of Sacramento and the Sacramento County Developmental Disabilities Planning and Advisory Council. Commissioner Buck earned a Master of Business Administration degree from National University. Commissioner Buck fills the seat of an employer with less than 500 employees.

Victor Carrion, M.D., Palo Alto

Victor Carrion, M.D., is a Professor at the Stanford University School of Medicine, and the Director of Stanford's Early Life Stress Research Program. He is a board certified Child and Adolescent Psychiatrist, and his subspecialties include maltreatment, neglect, and post-traumatic stress disorders. Dr. Carrion practices at the Lucile Packard Children's Hospital at Stanford. He is also an Associate Editor for the Journal of Traumatic Stress. His current research focuses on the relationship between brain development and vulnerability to stress, and developing treatments that include individual and community-based interventions for trauma-exposed children and adolescents. Dr. Carrion is also the recipient of awards from the National Institute of Mental Health, the American Foundation for Suicide Prevention, the National Association for Research in Schizophrenia and Affective Disorders, and the American Academy of Child and Adolescent Psychiatry. Dr. Carrion holds the Commission seat as the Attorney General's designee.

Lou Correa, Santa Ana

Lou Correa was elected to the California State Senate in 2006 and represents the 34th Senate District. He was elected to the Orange County Board of Supervisors in 2004 and prior to that he served in the California State Assembly. Senator Correa serves on the Senate Select Committee on Autism and Related Disorders and represents the Orange County Autism Regional Taskforce. He has also served on the Board of the Orange County Community Development Council, the county's Anti-Poverty Council, the California Small Business Board, the Orange County Boy Scouts, and the Orange County Mental Health Board. Senator Correa represents the member of the Senate selected by the President pro Tempore of the Senate.

David Gordon, Sacramento

David Gordon has been county superintendent at the Sacramento County Office of Education since 2004. He served at the Elk Grove Unified School District as superintendent from 1995 to 2004. He worked at the California Department of Education as deputy superintendent from 1985 to 1991. He earned a Master of Education degree from Harvard University. Commissioner Gordon holds a seat as superintendent of a school district.

Paul Keith, M.D., San Diego

Paul Keith has been medical director of behavioral health at the Wellpoint West Region of Anthem Blue Cross since 2000 and medical director for integrated behavioral health since 1992. Previously, he was medical director of the Behavioral Health Unit at Palomar Medical Center from 2000 to 2009 and associate medical director of the public sector program at United Behavioral Health from 1997 to 1999. Dr. Keith was medical director at Vista San Diego Center and medical director of the child and adolescent program at Alvarado Parkway Institute from 1987 to 1994 and owner and proprietor of Paul R. Keith M.D., A Medical Corporation from 1975 to 2009. He earned a Doctor of Medicine degree from Baylor College of Medicine. Dr. Keith fills the seat of a health care services plan or insurer.

Bonnie Lowenthal, Long Beach

Bonnie Lowenthal was elected to the California Assembly in 2008 and represents District 70. Assembly Member Lowenthal has a background as a licensed family counselor and mental health consultant, having received her Master's degree from California State Long Beach. She is Chair of the Assembly Transportation Committee and serves on the Assembly Health Committee. She has made the improvement of mental health services a legislative priority in the Assembly, including authoring Assembly Bill 739: Mental Health Curriculum, which would require the State Board of Education to include suicide prevention instruction as part of health education for grades 7 through 12. Assembly Member Lowenthal fills the seat of an Assembly member selected by the Speaker of the Assembly.

LeeAnne Mallel has been a psychological technician at the office of Dr. Jonine Biesman and a development floortime specialist in private practice since 2011 (a developmental model creates the relationships and keeps the child's strengths and weaknesses in mind so that children flourish). Christopher Miller-Cole, Psy.D., Oakland

Christopher Miller-Cole has served in multiple positions at the California Department of Corrections and Rehabilitation since 2006, including clinical psychologist at the Parole Outpatient Clinic. He held multiple positions at the City of Berkeley Mental Health Department from 2002 to 2006. Commissioner Miller-Cole completed clinical traineeships at New Leaf Services in San Francisco from 2000 to 2001, John George Psychiatric Pavilion in San Leandro from 1999 to 2000 and the Haight Ashbury Free Clinics Detoxification and Aftercare Program from 1998 to 1999. He was a research associate at the City and County of San Francisco Department of Public Health from 1995 to 1998 and a volunteer facilitator for the Stop AIDS (Acquired Immunodeficiency Syndrome) Project from 1994 to 1995. Ralph Nelson Jr., M.D., Visalia

Ralph Nelson Jr. was a radiologist and a partner of the Kern Radiology Medical Group from 1974 until his retirement in 1999. Dr. Nelson also worked as a radiologist at William Beaumont United States Army Medical Center from 1973 to 1974. He previously served as President of National Alliance on Mental Health Illness (NAMI) California Board of Directors from 2004 to 2008 and was a member of the California Collaborative Justice Court Advisory Committee from 2007 to 2010. Dr. Nelson currently serves as a board member of NAMI, is a member of the California State Licensing and Certification Advisory Committee, and is Chair of the Tulare County Mental Health Board. Commissioner Nelson holds a seat as a family member of an adult who has or has had a severe mental illness.

David Pating, M.D., San Francisco

David Pating is the Commission Vice-Chair. He is the Chief of Addiction Medicine and Medical Director of the Chemical Dependency Recovery Program for the San Francisco Kaiser Permanente Medical Center. He also serves as Northern California Regional Chair for Kaiser Permanente's Addiction Medicine Chiefs and Chemical Dependency Quality Improvement Committees. Dr. Pating has an academic appointment as an Assistant Clinical Professor in Psychiatry at the University of California, San Francisco School of Medicine. He was the President of the California Society of Addiction Medicine, a member of California Psychiatric Association, California Medical Association, and California Healthcare Association's Behavioral Health Advisory Board, and the California Institute of Mental Health Board. Dr. Pating fills the seat of a physician specializing in alcohol and drug treatment.

Larry Poaster, Ph.D., Modesto

Larry Poaster has served as a private consultant to government agencies in the field of health care delivery by public entities since 2002. He previously served as the Director of Behavioral Health Services for the Stanislaus County Department of Behavioral Health Services from 1980 to 2002 and was the Director of Clinical Services for that department from 1970 to 1980. Richard Van Horn is the Commission Chair. He has been President and Chief Executive Officer of the Mental Health American of Los Angeles since 1980 and President Emeritus since his retirement last year.
